



Scott Kerlin's Soccer Unlimited Private Lessons

This program's emphasis is on the education and individual, technical development of the child. It is highly interactive and is designed to allow players to develop at their own pace. Scott is a strong believer in positive reinforcement as a teaching tool and strives to create an enjoyable atmosphere where individuals can have fun while learning. The program imparts a basic understanding of the fundamentals of offense and defense. All skills taught are age-specific and reinforced with individual and group drills. Small group games are used to simulate actual game situations in order to cement techniques taught.

EXPERIENCE

Scott has been involved in organized soccer for over 30 years. He spent two years in the professional ranks in the United Soccer League with the Dallas Americans and in the American Indoor Soccer Association with the Louisville Thunder, Columbus Capitals, and the Fort Wayne Flames. He spent one year with the Phoenix Pride reserve team and two years with the Phoenix Inferno/Pride farm team, both of the MISL. He has also professionally coached the past 20 years for clubs such as the Dallas Americans, the American Generals, the N.E.T. Longhorn/Challenge, and the American Eagles. He is the Director of Coaches, managing a staff of coaches for the DFW Tornados Soccer Club. Scott currently holds a "D" State license, a USSF National Youth and a USSF "A" National license.

TOPICS & HIGHLIGHTS

This program will accommodate individuals age 6 and older from recreational through advanced levels.

Good habits and proper warm-ups and warm-downs are taught and strongly emphasized to prevent unnecessary injuries.

Technical Skills Workout form is provided to guide individuals at home.

Individual ball skills are taught in order to master 1v1 situations and achieve success in early developmental stages.

Tactical decision-making is incorporated in order to prepare players for a more advanced level of play.

Bring your own **water, ball** and **shin guards**.

RESERVATIONS

To reserve a place, notify Scott by phone or e-mail a minimum of two days prior to a lesson.

To reserve for the next week, write "YES" in the memo area of your check or on the outside of the envelope when paying in cash. (or phone or e-mail Scott)

If you made a reservation but cannot attend, you are required to notify Scott. When a 24-hour notice is not given, it is especially important that you contact Scott prior to the lesson.

Without a reservation you may attend a lesson, but understand that the lesson may be filled, previously rescheduled, or canceled.

Scott will contact you if a lesson is canceled due to inclement weather. Do not assume it is canceled until you have heard from him. Scott has the option of moving the lesson to a local indoor facility. If the lesson is held, but you do not attend, you will be responsible for the payment of that lesson.

Participant is responsible for payment when a 24-hour cancellation notice is not given.

Payment is required weekly prior to each lesson
